- 4. Financial Report** There has been no statement since October 2020 as no cheques have been written since September. A request for a donation of £500 for churchyard maintenance had been made. Sophie Farrell proposed and Adrian Pearse seconded the motion that this payment be granted. Other payments which need to be made before the next meeting were clerk's salary (before March 31st), SALC and insurance (both due in May). Everyone agreed that these payments be made. There were two signed cheques in hand. The clerk to liaise with the Chairman to organise signing the others.

6. Broadband Provision

No progress here. Voneus had been unable to get a line of sight to enable the Hall to receive broadband. Sophie Farrell to liaise with Anthea Derby on this.

7. Village Hall

Anthea Derby reported there was little news. Voneus had been using the hall. The county elections in May had been cancelled. Paul Heal queried the address for the Village Hall as the postman was confused as to where to deliver post. Anthea Derby said it should go to her address. The Chairman asked if meetings could be held there if the Rule of Six resumes - Anthea Derby said they could, though a broadband connection would be necessary in order to accommodate members of the public wishing to attend.

8. Parish Plan

Sophie Farrell suggested buying a map of the parish. After some discussion Sophie Farrell proposed that she would look into it and all agreed. Martin Dearden queried the need for a parish plan for East Pennard. Sophie Farrell offered to extract pertinent information.

These had all been circulated to the councillors; the Chairman asked each councillor if they had received and read each letter and all had. Sophie Farrell declared a personal interest and left the meeting after making a statement.

The Chairman noted that mediation had been suggested at the meeting in January; some residents had responded by saying that, in the circumstances, there was no possibility of mediation. A suggestion was made that the Commoners' Association could possibly invite the Giarettas to a meeting; Ben Giaretta said he was happy for this to happen. After some discussion amongst the 4 councillors as to a way forward, the general consensus was that the solution was beyond the capabilities of East Pennard Parish Council and as such the issue was something the parties needed to work out for themselves.
